SHOW INFORMATION:

1. The **cost** of an 8 ft. table is \$75.00. 2 for \$135.00. 3 for \$190.00. Additional tables at \$60.00 per table if approved by the promoter. Chairs will be provided. Bring any table skirts you wish to use for table covers as skirting will not be provided.
2. Set up time is from 8:00-11 AM preferably, the morning of the show. Move in/out is through the front or loading dock doors or back door to the left of Macy's. There is NO PARKING or UNLOADING at the front door entrance/curb at the bus stop up to the loading dock. Only at the curb at the back door.
3. The show will run from 11:00 AM until 5:00 PM and load out should be done after the show closes at 5:00 but you are free to come and go as you like.
4. Your exact location will be noted with a name card on your table(s).
5. Nothing may be affixed to any walls or Mall property. Tables must be lifted, not dragged.
6. Dealer contracts paid in full and received first will get priority table selection.
7. Dealers should be prepared to collect NY State Sales Tax and exhibit their tax certificate as required.
8. Mail the contract portion below along with your check payable to Rob Schilling for the number of tables selected.
